From September 2014 all children who are in Reception, Year 1 or Year 2 in a state-funded school will be offered a free healthy school lunch. Children in other school years will also be offered a free school lunch if their parent is receiving any of the qualifying benefits listed overleaf.

Registering could raise money for your child's school

Registering for free meals could raise an extra £1,320 (Primary School) or £900 (Secondary School) to fund valuable support like extra tuition, additional teaching staff or after school activities.

This additional money is available from central government for every child whose parent is receiving one of the qualifying benefits listed on this form. It is therefore important to sign up for free school meals, even if your child is in Reception, Year 1 or Year 2, so that your child's school receives as much funding as possible.

How the information on this form will be used

The information you provide on this form will be used by the council to confirm receipt of one of the listed qualifying benefits. Once this is confirmed, this helps to decide how much money your child's school will receive each year.

The information will also be used in relation to children in year 3 or above to decide whether they are eligible for free school meals.
